- Meeting Called to order at 5:35pm
- Approval of checks- S. Hatfield, 2<sup>nd</sup> L. Weber
- No leaks this month
- Elections for board members are coming up this spring. We will be posting to the website and sending an email to patrons to ask about interest.
- Planned projects are a valve on 2<sup>nd</sup> and Idaho and an alley behind Warm Springs between Maple and Elm St.
- Credit card limit needs to be raised to \$2,000 to allow for better cash flow. We are hitting the limit almost every month and if we need to pull a right-of-way permit it causes issues
- Discussed the best ways to communicate with patrons. Emails are best for quick communication. Voicemail greeting will be updated with website reference for updates.
- The Boise City intertie will be used this summer while the Mainline is replaced.
- Jeff Eggebraaten put together a spreadsheet to help estimate what we should be charged for domestic service.
- It was decided to form a committee to determine the best way to set domestic rates.
- City of Boise is requesting the rights to pump more of the geothermal water. A group of geothermal districts meet regularly to determine if they can safely have those rights. It has been determined that they can have more when they reach a certain point in the amount they are currently pumping.
- Liens for 2 properties have been recorded. Liens are required by both the District's bylaws and the contract with IDWR.
