- Jon Gunnerson notes a growing interest in geothermal from residential to commercial and even state/federal interest. Boise is looking at expanding a bit soon. Lots of people are liking how geothermal is useable regardless of weather and other factors. Many companies are pushing for green energy and efficiency and geothermal is perfect for that. Many buildings in Boise are currently on geothermal and several are coming on to the City of Boise system. Boise is looking at making sure their system is as efficient as possible. They will be restructuring their rates over the summer, not sure how that will look yet. Boise City will be likely asking for extension on water rights as they add buildings.
