- Jon Gunnerson and Tina Riley from the City of Boise Geothermal came in to discuss somethings. They have observations regarding the aquifer and hot basements. They have data showing the stability of the aquifer and the increase in the pumping. They also discussed the new spring that has emerged and has been address. Tina, a geological scientist, is curious whether the hot basements are related to the new spring in the park. We are monitoring all geothermal wells closely and have not seen major rises in the well depths. The City is going to take thermal images this winter to try to see anything. They have a drainage area they are considering using to release some pressure.
